

#### What is NMSIIS?

The New Mexico Statewide Immunization Information System (NMSIIS) is a statewide registry that tracks and records immunizations, generates immunization history and recommendations, and maintains detailed patients records for New Mexicans of all ages. NMSIIS is a confidential and secure computer database designed to collect and maintain vaccination records of children and adults. Utilization of the IIS promotes cost effective and efficient disease prevention, which leads to better health for New Mexicans.

# Why is Data Collection Important?

- Improves outreach efforts
- Helps to identify underserved populations.
- Assists Public Health professionals in making informed, quality decisions

### **Mandated Reporting**

Per <u>Senate Bill 58</u>, physicians, nurses, pharmacists, and other health care providers shall report all immunizations administered to NMSIIS unless the patient, or the patient's parent/guardian, if the patient is a minor, refuses to allow reporting of this information.

All administered immunizations must be reported to NMSIIS, including but not limited to, adult, pediatric, and employee vaccinations. Administered vaccines must be reported to NMSIIS per the reporting guidelines in the NMAC 7.5.5.

The New Mexico Administrative Code (NMAC) is the official collection of current rules (regulations) written and filed by state agencies to clarify and interpret laws passed by the legislature.

### Did you know, it's the law?

A provider is in noncompliance if they fail to follow these reporting regulations.
Section 7.5.5.16. has information on Sanctions and Noncompliance.

## **Current Reporting Requirements**

"Providers shall report **ALL data elements** to the registry for all immunizations they administer to a patient." (NMAC 7.5.5.9.A.)

(7.5.5.9) The following are the **minimum** data elements that must be reported to the registry:

- (1) Vaccine Information, including:
  - (a) name of vaccine
  - (b) manufacturer of vaccine
  - (c) lot/serial number of vaccine
    - (d) funding source of vaccine
    - (e) expiration date of vaccine
      - (f) NDC number of vaccine
- (g) date of vaccine administration
- (h) dosage administered to patient
  - (i) body site
  - (j) route of administration.

- (2) Patient demographic information, including:
  - (a) last name
  - (b) first name
  - (c) middle name, if applicable
    - (d) gender
    - (e) date of birth
    - (f) insurance status
    - (g) insurance information
      - (h) mailing address
      - (i) physical address
      - (j) contact information
        - (k) race
        - (I) ethnicity

### **Timeliness in Reporting**

Providers have specific time frames to report data elements to NMSIIS after immunization administration:

All
non-Covid 19
Vaccines:
10 days

Covid 19 Vaccines: 24 hours Mass
Vaccination
Events:
30 days
